Senoia Raceway (SR) reserves the right to refuse an application for membership. SR reserves the right to terminate any membership, at any time, with written notice to the member. Memberships are not transferable. No refunds. Members may discontinue their membership, at any time, by submitting a letter of resignation, to the SR offices in Senoia, GA. Acceptance of this application and fee by any SR official does not constitute approval of this application. All approved applications will be confirmed by SR and record of all memberships will be available at the competitor sign-in building on any event night.

I hereby apply for membership and authorize SR to represent my interests as they may appear in auto racing manners and consent to the use of my name, pictures of myself and my car for publicity, advertising and endorsements both before and after the events, and relinquish any rights to photos taken in connection with events and consent to the publication or sale of such photos as SR so desires.

By submitting this application and taking part in any activity relating to any event, I agree to abide by all rules and regulations of SR now or hereinafter promulgated and by the decisions of those officials relating to the event and agree that such decisions are final, non-appealable, an non-litigable, except as provided in the SR rule book. Such a competitor further agrees that the racing area is in a safe, raceable and useable condition, and that he/she voluntarily assumes the risk of, and has no claim for damages against SR, the Promoter, or their officers, directors, officials, sponsors, agents, or employees by reason of damage to either the car, the driver and/or the pit crew. All such competitors assume full responsibility for any and all injuries sustained; including death and property damage, anytime they are in the racing area or enroute thereto or therefrom. I agree that myself, heirs, executors and assigns will be entitled only to the benefits, if any, of the Competitor Accident Policy procured and in force by SR for accidental injuries which are the result of external, violent and visible means sustained in SR events of whatsoever nature. The foregoing shall constitute the limit of liability of SR for such injuries occurring to me in any SR event provided proper notification is given, unconditionally releasing and indemnifying regardless of SR negligence. This also shall not serve to limit or expand the "insurance release" waiver form or other contract that may be signed at other times.

In consideration of the acceptance by SR of this agreement, the undersigned recognizes his obligation to the public and SR, which posts the prize money and conducts the event, and agrees to compete in all events when qualified, if humanly possible. I am an independent contractor assuming all responsibility for money received as a result of my activities including but not limited to income tax, FICA, workers compensation and withholding taxes. I am not an employee, servant or agent of SR.

In the event the undersigned breaches this agreement, he shall be liable for actual and liquidated damages sustained by SR as a direct or indirect result of such breach.
